By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Gorilla Nation Media, LLC (“**Sponsor**”), 5140 Goldleaf Circle, 3rd Floor, Los Angeles, CA 90056, which shall be final and binding in all respects.

ELIGIBILITY: Only legal residents of the fifty (50) United States (and the District of Columbia) who are eighteen (18) years of age or older and located in the United States at the time of entry are eligible to enter. Sponsor, [Overture Films, LLC](#), and each of their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies and each of their respective officers, directors and employees (and immediate family members and those persons living in the same household of any such officers, directors and employees) (collectively, the “**Promotion Entities**”), are ineligible to enter the Sweepstakes or win the prize.

Sponsor shall not have any liability for any winner notification that is not received by the potential winner for any reason. PRIZE/ODDS: One (1) Grand Prize is available. The Grand Prize winner will receive the Grand Prize consisting of One (1) Xbox 360 system (Approximate Retail Value "ARV" \$199.99 USD), One (1) Left 4 Dead Xbox 360 game (ARV \$29.99 USD), one (1) Dead Space Xbox 360 game (ARV \$27.99 USD), and one (1) Condemned 2: Bloodshot Xbox 360 game (ARV \$14.99 USD).

The approximate retail value of the Grand Prize is \$272.96 USD. Prizes are non-assignable and non-transferable. No cash alternative or prize substitutions will be allowed except that Sponsor retains the right to substitute a prize of comparable or greater value (or at Sponsor's election, the cash value of the applicable prize) in the event a stated prize is unavailable, in whole or in part, for any reason.
